## <Septic tank>

This is a device for treating household wastewater in a toilet, kitchen, bathroom, or the like. This device is adapted to all facilities in which household wastewater is produced.

#### <FCE type Septic tank>

The photograph in the upper left portion shows the most compact septic tank for a detached house.

This septic tank was the first to be certified as one to which an "Eco-mark" was assigned.

In actual use, electric power consumed by the blower is minimum. Electricity charges can be reduced by about 40 percent compared to that product of another company which has the largest share in Japan. The energy saving performance is the highest in Japan.

#### <FCW type Septic tank>

The illustration in the lower left portion shows a septic tank for a large-scale facility such as an apartment house, a store, a hotel, an office building, or the like. By arraying a plurality of tube-like objects of this type, it is possible to cope with facilities of various sizes.

As for the most common treatment performance of septic tanks in Japan, BOD for treated water is 20 mg/L.

Both of the above septic tanks has performance such that the newly formulated Indonesian wastewater standard can be fully met.

From now on, not only is it intended to sell products having Japanese specifications, but also it is planned to develop new products complying with the environmental requirements and the wastewater standard in Indonesia, and to produce these products on-site.

As for on-site production of newly developed products, it is possible to hold down sale prices, thereby selling these products at prices that match on-site circumstances.

- Toilets are converted to flush lavatories, resulting in the realization of hygienic toilet environment.
- · Only a slight foul odor is produced.
- Treated water quality is so excellent that contamination of public water areas is prevented.
